3-Class Basketball Proposal

Presented to the North Dakota High School Activities Association by the North Dakota Focus Group

For Consideration for the 2023 – 2024 Season

November 1, 2022

General Information

The enclosed proposal is for consideration for the North Dakota High School Activities Association (NDHSAA) for a 3-Class Basketball system to be started in the 2023-2024 school year.

The proposal is presented before the Board of Directors based on information gathering, feedback from member schools, dialogue amongst schools, and several meetings. Based on the survey created several months ago about the interest in a 3-class basketball plan, there was a significantly high interest in creating a plan from the member schools. To create the right plan for the membership to consider is the challenging equation in the process. Although no plan created will be perfect for all, the belief is that the enclosed plan will provide a better framework for implementation in the sport of basketball in the coming years than the current framework in place in promoting the sport of basketball.

The following representatives were part of the focus group in gathering feedback from each geographical area and have provided this feedback in the proposed plan.

To be considered by the NDHSAA board of directors, 60% of member schools with a boys basketball team, will be needed to support the enclosed plan. The focus group would need a letter of support on the enclosed plan **between October 1**st & October 31st, 2022 for this to be considered for implementation in the 2023-2024 school year.

The following plan was based upon the focus groups consensus decision making. Although not all decisions made by the focus group were unanimous in nature, there has been good discussion, input, and dialogue on all aspects of the proposed plan. The focus group would like to take feedback from member schools and make any changes to the plan based on the best interests of the framework of the plan. This input will be taken till September 28th (Wednesday) for consideration of changes to the plan. Final plan will be released after September 30th.

The following is NOT a NDHSAA staff or board of director's plan. The goal is to present the plan to the NDHSAA staff and board of directors in the near future. If you have any questions, comments, or input on the proposed plan, contact one of the people in the focus group listed.

Guiding Principles of the Plan

- To promote a competitive balance in the sport of basketball to foster an increase in participation in the sport
- To maintain or increase the number of basketball teams
- Demographics have changed in North Dakota
- Participation in the sport of basketball has dramatically decreased over the years
- To create more opportunities for more students.
- Students not attending their geographical school of residence at a public school will be assigned a multiplier factor for enrollment classification.
- The plan will be presented during the months of August and September for input and possible changes. Alterations in the plan will occur if deemed necessary by the focus group. A final plan will be completed on October 1st, 2022 and passed to member schools.
- Between October 1st & October 31st, the focus group will be soliciting schools to show support with a supporting letter for the proposed plan. This plan and letters of support to be presented to the NDHSAA on November 1st, 2022.
- Any school disbanding a co-op prior to the 2023-2024 season should notify the NDHSAA for classification purposes.
- Schools may opt up a class but cannot opt down a class
- This plan to provide the framework for the sport of basketball and with other sports to possibly follow if practical in that specific sport.
 - Other sports may follow this framework or a modified outline if successfully implemented. ex. Volleyball
 - What may work in the sport of basketball may not be as workable in other sports
 - o Each sport is unique in its framework for implementation.
 - Ex Football uses male enrollment, basketball utilizes total enrollment
 - State tournament formats and implementation are unique for their specific sport
 - Implementation of fall sports for a 3-class plan have a different timelines for consideration.
 - Girls' golf a plan would need to be presented to the NDHSAA by August 1st,
 2022 for implementation next year with 60% approval from schools.
 - Girls 'Volleyball a plan would need to be presented before August 15th to the NDHSAA for consideration for the 2023-2024 season with 60% approval from schools.
 - At the time of this writing, the earliest for a 3-class plan for volleyball implementation that can be considered is for the 2024-2025 school year.

Framework

- 1. Classification of school will be in 3 classes of basketball with the following cutoffs:
 - a. Class AA Enrollment of 575 +: The average of grades 9-12 in the fall of 2021 and Fall of 2022
 - b. Class A Enrollment of 180 574 students: The average of grades 9-12 in the fall of 2021 and Fall of 2022
 - c. Class B Enrollment below 180 students: The average of grades 9-12 in the fall of 2021 and Fall of 2022

- 2. Enrollment numbers will be obtained from DPI after September 15th, 2022 for students in grades 9-12 for enrollment classification.
- 3. The enrollment / classification occur every 2 years. Next classification period will be after September 15th, 2024 in grades 9 through 12 with numbers obtained from DPI.
- 4. Any "Out of Zone" student will have a multiplier factor of 2.0 to be added to the enrollment count in grades 9-12 for each year.

"Out Of Zone" Students

- 1. Residence for students will be defined according the NDSAAA by-law Article XIV Section IX:
 - a. "Residence" shall be defined as the place where the student's parents have established their permanent home. This means that the family regularly eats and sleeps in a specific place of lodging. It is the place where the student and the student's parents are habitually present and to which when departing, they intend to return.
- 2. All students are assigned a school to attend which is based on their place of residence to a public school.
 - a. Cities that have more than one school in their school district boundaries will abide by the boundary lines drawn by the local district school board
 - b. School District boundaries / residence are determined by the state of North Dakota governing body who determines boundary lines for school districts.
- 3. Any students wishing to attend a school district other than the one assigned to their public school district by their place of residence would be considered a "out of zone" students.
- 4. A multiplier factor of 1.0 will be assigned to all students in the enrollment count for each of the two years for those students in grades 9-12 when classification of schools occurs for out of zone students.
 - a. Ex open enrolled students, non-tuition students, private schools, charter schools, etc...
 - b. If a student attends a public or private school, which is not their assigned district will have the multiplier of 2.0 added to the enrollment.
 - i. EX A student is counted as 1 for the school they are enrolled in. If not attending in their assigned school district, an added 2.0 will also be added to that student.
- 5. Co-Ops will not have a multiplier factor for those out of zone students with those participating schools that are involved in a co-op. No multiplier for those students.
- 6. Numbers will be received from DPI to determine the number of out of zone students in grades 9-12 every two years.
- 7. Schools are responsible to provide to the NDHSAA any students who should not be considered an out of zone students in a participating co-op.
 - a. Those numbers / students should be provided to the NDHSAA if a school feels this would move them down a classification from the preliminary enrollment numbers.
 - b. Any schools not counting or classifying students as out of zone students may be ineligible for post season tournaments during the classification period as deemed by the NDHSAA board of directors. This may only be enforced if the results of not counting those out of zone students would have caused the participating team to move up a class.

Notes on the Scenario

- Enrollment numbers were taken for grades 9th 12th grade from DPI enrollment numbers for the 2021-2022 school year.
 - \circ Numbers for the plan will utilize grades $9^{th}-12^{th}$ for the 2022-2023 school year after September 15th number count from DPI
 - The scenario includes students in grades 8th − 11th from 2021-2022 school year.
 - Out of zone numbers were also be obtained from DPI for students in grades 9-12.
 - o Co-ops include total enrollment of all schools in grades 9-12.
- Out of zone, students were calculated for only students in grades 9th 12th of 2021 2022 from DPI enrollment numbers
- Students in out of zone multiplier includes students within the co-op.
 - At the current time, the focus group does not have access to out of zone students that participated in a co-op.
 - With a co-op and out of zone students, those students will not have the multiplier.
 - More than likely, most schools involved in a co-op will have a decrease in the enrollment number based on the multiplier factor.
- Setup is based on the 21-22 numbers for grades 9-12 and also for grades 8-11. As the enrollment fluctuates for 22-23, the teams for classification, region, and district classification will change also.
- Some school enrollments are estimates that have more than one school in a district (Fargo South, Bismarck Century, etc...)
- Private Schools are estimates based on enrollment numbers from the NDHSAA yearbook.
- School Districts only serving grades K-8 may not been included as of this writing.
- Placements in Districts / Regions are based on the 2021 2022 numbers.
 - These maybe subject to change based on changes in placement in classification.
 - Borderline schools on Districts / Regions maybe subject to different placement
 - Based on number of teams in District / Region
 - Geographic location for travel
 - NDHSAA will determine final placement of teams
- For the future plan for 2023-2024 enrollment will be taken from Department of Public Instruction enrollment count for grades 9-12 after September 15th.




