2014-15 REGION II SUPER REGION PROPOSAL

Below are some of the details of the Super Region plan that we are proposing. There would need to be more of the details worked out but this is a starting point.

- Patty Aanenson from Larimore has agreed to be the contact person for seeding, playin officials, tie breaking, etc.
- All teams in the region will play each other at least once during the regular season. If teams play once it will be worth 2 points and if they play twice, each game will be worth 1 point.
- Currently there are 14 teams in volleyball, so the #1 seed and #2 seed will get a bye and the remaining teams will play-in to get to the regional tournament. Games will be played at the site of the higher seed: #3 hosts #14, #4 hosts #13, #5 hosts #12, #6 hosts #11, #7 hosts #10, and #8 hosts #9. There are 13 teams in boys and girls basketball, so the #1, #2, and #3 teams will receive byes and the remaining teams will play-in to get to the regional tournament. Games will be played at the site of the higher seed: #4 hosts #13, #5 hosts #12, #6 hosts #11, #7 hosts #10 and #8 hosts #9.
- Play-in Games
 - Patty Aanenson will be responsible for contracting and assigning officials
 - We would need 14 officials for volleyball and 15 officials for basketball
 - Host team is responsible for the following obligations
 - Will pay for all tournament workers according to established fee schedule
 - Will pay for all tournament officials according to fee schedule
 - Will find and pay qualified line judges for VB
 - Submit financial report to Region tournament manager
 - All profits after expenses are paid will be sent to Region tournament manager
 - All money from the play-in games would be included in the Region financial that would be income for the NDHSAA.

- Basketball Tie Breaking Procedure
 - 1. Region record
 - 2. Head to head amongst tied teams
 - 3. Head to head with all teams in Region II play. Starting with the #1 team in the final standings, compare records versus each team in descending order until the tie is broken. Tied teams are considered to be in the same positions and total record versus all teams involved will be used.

*If a team is seeded, the remaining tied teams revert back to #2

- 4. Point spread against tied teams (maximum 15 points)
- 5. Coin toss
- Volleyball Tie Breaking Procedure
 - 1. Region record
 - 2. Head to head amongst tied teams
 - 3. Head to head with all teams in Region II play. Starting with the #1 team in the final standings, compare records versus each team in descending order until the tie is broken. Tied teams are considered to be in the same positions and total record versus all teams involved will be used.

*If a team is seeded, the remaining tied teams revert back to #2

4. Sets won against tied teams

*If a team is seeded, remaining tied teams revert back to #2

5. Sets lost against tied teams

*If a team is seeded, remaining tied teams revert back to #2

6. Point spread differential amongst tied teams

*If a team is seeded, remaining tied teams revert back to #2

- 7. Coin toss
- All Region Team
 - Volleyball will have 15 members
 - o Basketball will have 12 members
 - o Ties will be broken until the team is down to the appropriate number
 - o No honorable mention team will be presented

The Region #2 schools request that we be able to play two additional matches/games to offset any loss of revenue and to maintain the approximate matches/games that other Region schools are provided.

Region #2 request for a two (2) year trial period for both parties to determine if it is beneficial for the Region schools and the NDHSAA as a whole beginning with the 2014 Volleyball schedule.
