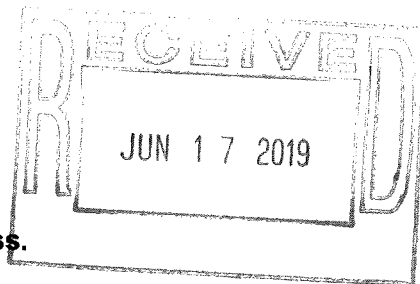


NDHSAA Coop Application
