## Playoff Performance Factor

- a. Teams shall earn the following point values for the final level of the playoffs they
  - i. Eliminated in quarterfinal One (1) point
  - ii. Eliminated in semifinals Two (2) points iii. State Runner-Up Three (3) points

  - iv. State Championship Four (4) points
- b. Division AA, A, and 9-man teams achieving twelve (12) points or greater due to playoff performance during a four-year period shall move up to the next largest division for the next two seasons. Teams may appeal this move to the classification committee.
- c. Teams that have achieved eight (8) points or greater due to playoff performance during four consecutive years as an opt down team shall move up to the next largest division for the next two seasons. Teams may appeal this move to the
- d. After participation in a larger division for two years, a team achieving a two-year total playoff performance point value of two points or below shall be eligible to move
- e. After participation in a larger division for two years, a team achieving a playoff performance point value of three or more points shall remain in the same division for the next two seasons.
