DIVISION B

DISTRICT 1

Kraft proposed allowing individuals to participate in 7 quarters per day in basketball in conjunction with Wolf (A Region 1).

Division B vote: Yes 2, No 4 - Failed

Division A vote: Yes 1, No 2 - Failed

Kraft proposed reducing warm-up periods from 25 minutes to 20 minutes in volleyball.

Division B vote: Yes 6, no 0 - Passed

DISTRICT 2

Isaacson proposed allowing weigh-ins at home before departure in wrestling.

Division B vote: Yes 4, no 2 - Passed

Isaacson proposed rotating state qualifier game times between the A and B divisions in basketball and volleyball.

Division B vote: Yes 6, no 0 - Passed

DISTRICT 3

Aanenson proposed rotating state qualifier region matchups in conjunction with Wolf (A Region 1) and Wiberg (A Region 2).

Division B vote: Yes 6, no 0 - Passed

Division A vote: Yes 3, no 0 - Passed

Aanenson proposed reformatting the Class B East Region dual format in wrestling.

Aanenson recommended no vote at this time.

Districts 4 through 8 had no recommendations.

DIVISION A

REGION 1

Wolf discussed shortening the track and field season by moving the first allowable practice 2 weeks later.

Wolf discussed halves versus quarters in Division A basketball.

Wolf discussed adding two weeks to the basketball season.

Wolf discussed using AA, A, and B divisions for basketball, but splitting the B division into 11-man and 9-man divisions.

Wolf discussed season overlaps.

REGION 4

Foss discussed seeding the four region champions 1 through 4 for the state tournament.

Foss discussed playing region tournaments on Monday, Tuesday, and Wednesday of the respective region tournament weeks in basketball.

Foss discussed playing region quarterfinal games at the home of the higher seed in basketball.

Regions 2 and 3 had no additional proposals or discussion items.
