**New England Public School has historically co-oped in Boys' and Girls' Golf with Dickinson Trinity for boys and previously with Heart River for girls; however, participation numbers from New England have consistently been very low or, at times, nonexistent. Mott/Regent Public School has also sponsored golf teams in the past but has similarly struggled to field enough participants to compete as a full team.**

**The Hettinger County Co-op Committee discussed bringing the schools together to address these ongoing participation challenges. By forming this co-op, the intent is to combine student numbers in order to provide a sustainable golf program that allows students to compete as a team rather than solely as individuals, while ensuring continued access to the sport for student-athletes from all participating schools.**
