MINUTES

North Dakota High School Activities Association January 19, 2017, Valley City, ND

The Board of Directors of the North Dakota High School Activities Association held their meeting on January 19, 2017 in Valley City. President Rinas called the meeting to order at 10:15 am.

The proposed coops between Watford City and Johnson Corners were discussed. There are inaccuracies in the coop applications. The Board directed staff to contact Watford City for clarification and correction of applications before the March 2017 meeting.

Motion by Vollmer to table action on the Watford City and Johnson Corners coop applications as per discussion. Second by Stedman. Motion carried unanimously.

Brad Rinas, Executive Committee Chair, reported committee actions.

- Turtle Lake-Mercer reported students participating in a game when they had not been in school
 the first day of the semester. The students were not transfer students. On the first day of the
 semester roads were closed and students were not able to travel in order to get to school but
 were able to travel in time for the game. The Executive Committee waived the requirement and
 referred a potential By-Law amendment to the Constitution & By-Laws Committee.
- Shanley High School reported a coop issue. Shanley High School is cooped with St. Joseph's Middle School in Moorhead. St. Joseph's was allowing students to participate in two different cooperative sponsorships in the same sport. Some students participated at Shanley and other students at Horizon Middle School in Moorhead in girls basketball. NDHSAA By-Laws allows cooperative sponsorships with only one school per sport. The situation has been rectified by Shanley High School and St. Joseph's Middle School. A letter of reprimand and a \$500 fine were administered. Any further violations may result in the immediate dissolution of all Shanley and St. Joseph's coops.
- Grand Forks Public Schools reported a jr. high home school student participated for their schools while attending school in East Grand Forks. When this was discovered by Grand Forks Public Schools participation ended immediately. Letter of reprimand was issued.
- Beulah High School reported a girls basketball player exceeded the nightly quarter participation limit. Prescribed penalty was administered with a letter of reprimand and forfeiture of games in which the ineligible student participated
- Solen High School reported a violation of the 9 practice rule. Prescribed penalty administered with letter of reprimand and forfeiture of all games in which the ineligible student participated.
- The committee reviewed a late coop dissolution request:
 - o Shanley and St. Joseph's (MN) in football, 7-8, 2017-18
 - o Forwarded request to the Board for action.
- Committee denied a request from Shanley to waive the late coop fees for baseball and softball.

Motion by Manley to approve the Executive Committee report. Second by Bertsch. Motion carried unanimously.

The Board acted on a late coop dissolution request:

Motion by Schafer to approve coop dissolution. Second by Dahlen. Motion carried unanimously.

Scott Privratsky, Finance/Personnel Committee Chair, reported on the following:

- (1) Recommend a 4% increase for staff salaries for 2017-18. Directed Executive Director Fetsch to visit with staff concerning 4% raises in the future. The finance committee would like to continue to increase team payments, if possible.
- (2) Recommend a 2-year bid extension with Officeworks of Valley City for the NDHSAA directory with the following increases.
 - a. 2017/18 \$ 2,994.75
 - b. 2018/19 \$ 3,157.25
- (3) The committee directed Executive Director Fetsch to gather staff input and bring tournament manager fee recommendations to the March Board meeting for review.
- (4) Recommendation to change the football playoff financial reports. Changes include combining some categories and placing a maximum on some categories.

Motion by Vollmer to approve the Finance/Personnel Committee report. Second by Sorlie. Motion carried unanimously.

Mitch Carlson, Constitution & By-Laws Committee Chair, provided the Board with a committee report.

• Medical marijuana and the effects on eligibility was discussed. The legislature is working on clarification of the law during the current legislative session.

- Rules of Eligibility for attendance, Article XIV, Section I, were discussed. The committee is considering drafting an amendment to the By-Law concerning attendance by the 11th day of the semester for students enrolled in schools through the prior semester.
- Article XIV, Section IV: Questions and Answers were discussed. Upon discussion, Executive Director Fetsch was directed to make edits as discussed to present to the committee in March.
- Discussed offering an electronic ballot for the Board member elections.

Motion by Carlson to approve the Constitution & By-Laws Committee report. Second by Schafer. Motion carried unanimously.

Todd Bertsch, Media Committee Chair, provided a committee report concerning media coverage with current broadcast contracts.

Bertsch explained there are currently two tiers of coverage for NDHSAA post season events. Tier I events are televised on state wide television. All other events are considered Tier II and are currently covered by the NFHS Network contract. Tier II events not produced by the NFHS Network are available for resale. Committee recommends a Tier I and Tier II package with a recommendation to have both tiers bid with contracts beginning in the 2018/19 school year. Tier II would include all region and state tournaments not currently covered in the Tier I television contract. Staff is directed to bring request for proposal recommendations to the March Board meeting. The bidding process would include a timeline to approve contracts at the August 2017 Board meeting. Motion by Manley to approve the media committee report. Second by Dahlen. Motion carried unanimously.

Brad Rinas, Tournament Committee Chair, provided recommendations for 2017 Fall Region Tournament sites.



Motion by Privratsky to approve 2017-18 Board meeting and Fall Regional Administrator Meeting dates. Second by Vollmer. Motion carried unanimously.

The Board reviewed the existing cooperative sponsorship (coop) By-Law, guidelines and naming recommendations. The philosophy of cooperative sponsorships was discussed including the size and length of coop agreements. Members indicated reasons for schools to form coops vary from school to school. Offering a sport via a coop often allows students to participate in a sport that would not be possible for them to participate in without a coop. Some coops are formed to become competitive, some coops are formed to allow participation. The Board is cautious to implement regulations that limit

participation. The coop forms were discussed. The addition of the status of students cut from program as a question on the form was also discussed. The addition of the question "Have you cut students from your program?" may be something to add.

The Board reviewed the current Hardship Eligibility Procedure. The Board discussed what, if anything should be added to the procedure to assist in making hardship determinations. Addition of the question "Was the transfer athletically motivated?" was discussed.

 - ii. Another Senate Bill of interest mandates the state of North Dakota reject all federal funding when there are requirements set by the federal government.
