### District Chairperson Notes Minot – Clarion Hotel and Conference Center March 15, 2019

The Class B District Chair meeting was held on March 15, 2019 at the Minot Clarion Hotel and Conference Center. Chairman Schafer called the meeting to order at 9:00 a.m. with 14 districts represented. Upon introductions, Chairman Schafer welcomed the district chairpersons and thanked them for representing their district.

The Executive Director thanked the member schools for past service as district chairs. Sheets were distributed requesting information on the 2020 basketball district chairperson and each district's recommendation for district and region sites, dates and managers. Fetsch informed the chairs of the approval process and timeline for approving district and region sites. Items preceded by an asterisk (\*) were items voted on while other items were for discussion only. Items approved by nine of more of the districts in attendance are forwarded to Athletic Review for consideration. Fetsch also explained only district chair recommendations approved by Athletic Review will continue to the NDHSAA Board for review.

Each district was given the opportunity to present their district's recommendations and discussion items, which are listed as submitted.

#### District 16----Ryan Eraas, AD Tioga HS

- 1. In basketball, extend the coach's box to the baseline
  - a. Discussion: Fletschock discussed history of coaching box implementation, including the current 14-foot coaching box being placed wherever.
  - b. Vote: No (1-13) Failed
- 2. Change the state ball bid in basketball to the Baden Elite or the Wilson Evolution instead of the Spalding. College use and ball durability are the reasons
  - a. Discussion: Fetsch discussed current contact which runs through 2021. Durability is number one concern with current ball that is adopted.
- 3. Interested in a 3-class system, initiated by the state, not a proposal voted on that a school makes.
  - a. Discussion: Fetsch updated the district chairs on the Board timeline for development of a regulation to add a classification to all sports and activities. Jung said District 13 is in favor of three classes of basketball. DesRosier mentioned a couple of regions have been dominant in boys basketball, but not in girls basketball. Dennis commented that Region 1 teams farther from Fargo seem to favor three classes while schools closer do not. Hunter noted that superintendents voted on most recent survey and other did not see plan.

#### District 14----Andrew DesRosier, AD Killdeer HS

- 1. In Golf and Cross Country, unattached/exhibition/transfer student athletes may compete at a varsity meet, but must meet the following criteria:
  - a. The meet does not offer a JV division
  - b. The meet is not a post-season meet
  - c. The athlete cannot place, score points, nor be used as a displacer in team scoring
    - i. Discussion: DesRosier discussed adding golf and cross-country regulation similar to track and field and swimming and diving.
    - ii. Vote: Yes (14-0) Passed

#### District 13-----Daryl Jung, AD New England HS

- Eliminate the 126 quarters a player may participate in during a regular season of a Super Region and the 120quarter limit for Class B Region#1 and any Class B player participating in District Tournaments may not participate in more than 114 quarters in a regular season
  - a. Discussion: Jung said with the large number of small schools in their area it's becoming harder to field sub-varsity teams. Nieuwsma mentioned with the 6 quarter rule kids play a full quarter with the current rule. DesRosier expressed concern over kids losing playing time if quarters were unlimited. Hunter mentioned that District 15 adjusted junior high season to help with 16-week rule. Fitzgerald mentioned instance of teams playing varsity players in sub-varsity games. Krueger said District 12 moved junior high season later next year to avoid issues with 16-week rule and added if you can't fit a junior high season within the 16 weeks your season is too long. Beaudrie said they are moving all eighth graders up to high school next year because of numbers.

#### District 5-----Lucas Isaacson, Principal/AD LaMoure HS
