Attendance Restrictions

- *Tickets not available to general public
- *Two tickets per participant (home and away teams) masks are required for all fans

Media Allowances

- *NDHSAA contracted television/streaming partners
- *One radio purchased rights holder maximum per team, as designated by participating teams. Maximum of two credentials per station.
- *One newspaper credential maximum per team, as designated by participating team. Maximum of two credentials per newspaper.

Yellow Counties

Attendance Restrictions

- *Two tickets per participant (home and away teams) masks are required for all fans
- *If player ticket distribution does not exceed 100, unsold tickets may be sold by the host school.

Media Allowances

- *NDHSAA contracted television/streaming partners
- *One radio purchased rights holder maximum per team, as designated by participating teams. Maximum of two credentials per station.
- *One newspaper credential maximum per team, as designated by participating team, Maximum of two credentials per newspaper.

Green Counties

Attendance Restrictions

- *Two tickets per participant (home and away teams) masks are required for all fans
- *If player ticket distribution does not exceed 200, unsold tickets may be sold by the host school

Media Allowances

- *NDHSAA contracted television/streaming partners
- *One radio purchased rights holder maximum per team, as designated by participating teams. Maximum of two credentials per station.
- *One newspaper credential maximum per team, as designated by participating teams. Maximum of two credentials per newspaper.

Blue Counties

Attendance Restrictions

*No attendance limitations – masks are required for all fans when social distancing cannot be maintained.

Media Allowances

Regular NDHSAA media policies apply
