Jeremy Brandt, Finance/Personnel & Policy Committee Chair, provided a committee report.

- 1. 2020-21 staff contracts were discussed by the committee. NDHSAA staff contracts for 2020-21, were previously approved with a 5% raise. Due to financial concerns for 2020-21, staff raises were not provided to staff. The committee recommends providing the 5% raise for 2020-21 retroactively. With the proposed raise, assistant director salaries and staff salaries seem to be in line with surrounding states. The committee recommended a 5% raise for Matt along with a 3% retainer bonus as outlined in his current contract for a total of 8% for 2020-21. Motion by Fridley to approve a 5% raise for 2020-21 for all staff with an additional 3% for Fetsch as per his contract. Second by Jundt. Motion carried unanimously.

- 3. NFHS Summer meeting will be held in Orlando, Florida from June 28 July 2, 2021. Recommendation to allow NDHSAA Board and staff to attend the summer meeting as outlined in the NDHSAA Policy Manual.

Recommendation to table the Region 3 girls basketball site until the June Board meeting. Jordan urged the committee, in the future to look at options other than Dickinson Trinity for hosting Region 7 tournaments. Jundt indicated District 13 and 14 both recommended Dickinson Trinity as the site for Region 7 boys and girls basketball tournaments and the Tournament Committee relies on the recommendation of both districts. The Board discussed the philosophy of region sites and how recommendations are made through the Tournament Committee. Motion by Brandt to approve the Tournament Committee report. Second by Diegel. Motion carried unanimously.

Paul Jundt, Combined Tournament Committee Chair, provided a committee report.

3. 7-year calendar

- a. The change in the NDHSAA Football Plan now allows the ability to place calendar dates in football for 7 years as they are for all other sports and activities.
- b. For the 2021-22 school year, Superintendent Baesler did not designate a specific conference where school and contests would not be allowed as has been done in past years. Games/contests may be scheduled in October over the NDCEL administrator conference or the ND United conference.
- 4. The possibility of including Valley City in the state gymnastics rotation was discussed.
- 5. The number of name badges/floor access per team was discussed. Recommend NDHSAA staff work on wording for name badges/floor access per team.
- 6. Awards presentations/media interview policy was discussed to assure players are not detained for interviews during awards presentations. Mix indicated a protocol has been implemented and media will be informed of the protocol before tournaments.
- 7. Recommend high school affiliated media have a maximum of two passes per team and a requirement the media person must be a student.
- 8. Commercial photography at post season tournaments was discussed.
- 9. Managers are in support of implementation of online programs going forward.
- 10. Media row changes were discussed such as only allowing radios stations covering games being played at the time being allowed on media row.
- 11. Mix created a report covering how many games each media outlet covered. Tournament managers found the report extremely helpful.
- 12. There was discussion of awards/presentations and what should be brought back to tournaments in following years. Feedback indicated not having an awards presentation was disappointing to fans and remote viewers. Players are introduced at the beginning of the tournament and the opinion of the committee indicates there is no need to introduce each player again at the end the tournament. Announcing region athletes of the year was also discussed at length.
- 13. Tournament formats were discussed. Class A east and west region formats are being discussed in each region.

Motion by Schoch to approve the Combined Tournament Committee report. Second by Fridley. Motion carried unanimously.

Fetsch provided a Realignment Committee report. Recommend Realignment Committee review all regions in June and provide recommendations for a realignment to be in place for 2022-23 to Board. Motion by Bertsch to approve the Realignment Committee report. Second by Jundt. Motion carried unanimously.

Alexis Baxley, Fine Arts Committee Chair, and Brian Bubach provided a committee report. The Fine Arts Committee met to review two items:

- 1. Upcoming fine arts seasons, regulations and formats.
- 2. 2021 State Class A Plays attendance limits and dressing rooms.

The committee reviewed potential upcoming season surveys and discussed feedback role in decision-making. Discussion was also held regarding parent attendance and dressing room availability at 2021 State A Plays. Staff relayed limited attendance opportunity at State A Plays and expressed scheduling concern with dressing room usage and cleaning within approved scheduled. Committee recommendation to not allow use of dressing rooms for State A Plays as adjudication is not based on costumes.

The Fine Arts Committee recommends the following:

- 1. Authorize staff to survey administrators regarding upcoming arts seasons.
- 2. Amend 2021 State A Plays plan to allow for parent attendance within Lake Region State College campus policy.

Motion by Johnson to approve the Fine Arts Committee report. Second by Fridley. Motion carried unanimously.

The seven-year activity calendar was reviewed with proposed calendar dates through 2027-28. Motion by Schoch to approve the seven-year activity calendar through 2027-28. Second by Brandt. Motion carried unanimously.

NDHSAA sanctioning of girls wrestling was discussed. Morast indicated 79 girls competed in wrestling for 2020-21. Recommendation for NDHSAA sponsorship of girls wrestling for individual tournaments with one classification. All girls would wrestle in the girls classification as individuals. In order to compete in the team competition, girls would be part of the boys wrestling team for their school. Morast indicated the girls individual tournament could be combined into the current state tournament with modifications to the schedule. Motion by Jundt to approve NDHSAA sanctioning of girls wrestling for 2021-22. Second by Johnson. Motion carried unanimously.

The Board reviewed a request from the west region activity directors to change the region small group orchestra contest to a cumulative region/state contest. Bubach requested the Board forward the request to the Fine Arts Committee. Motion by Jundt to forward the request from west region activity directors to change the region small group orchestra contest to a cumulative region/state contest to the Fine Arts Committee for review. Second by Bertsch. Motion carried unanimously.

The Board reviewed a request from Jerome Slag, District 9 Chairperson, and Jason Ermer, District 10 Chairperson, for Region 5 to move to a super region format for boys and girls basketball beginning in 2021-22. Motion by Brandt to approve the Region 5 request to use a super region format for boys and girls basketball beginning in 2021-22. Second by Fridley. Discussion the possibility of changing the format of all super regions to a standard format at a future meeting. Motion carried unanimously.

NDHSAA Board meeting dates for 2021-22 were discussed. Motion by Jundt to approve NDHSAA Board meeting dates for 2021-22. Second by Schoch. Motion carried unanimously.

Representative Reports

1. Bertsch indicated a parent is interested in attending the State A Play production for their school. Fetsch indicated NDHSAA staff will respond and inform schools.

Executive Director's Report

- 1. Technology Director position update: Applications close on March 31, 2021 with interviews on April 7, 2021. A conference call committee meeting for the Personnel Committee and a conference call Board meeting may be requested to approve a new technology director.
- 2. Hardship/Extra Semester Waiver Report: Four hardship applications have been processed. One hardship was approved and three were denied.
- 3. The NFHS Summer Meeting was discussed previously in the Board meeting.
- 4. Fetsch provided a legislative update.
 - a. HB 1075, which eliminates restrictions on activities during the fall administrator conference was signed into law last week. This may facilitate future discussion about NDHSAA State Cross Country meets.
 - b. HB 1298, a transgender bill allowing individuals to participate in athletics only under the sex assigned at birth was amended several times. Amendment was approved to make this into a study sending it to conference committee. After conference committee review this may or may not come back to the legislature for a vote.

Next Board meeting will be June 7-8, 2021 in Valley City at the NDHSAA Office. Meeting adjourned March 30, 2021 at 11:08 am.
