

NDHSAA TOURNAMENT CODE OF CONDUCT

PURPOSE: To elevate standards of Good Sportsmanship and to encourage the growth of responsible citizenship among the students, member schools and their personnal.

Fundamentals of Good Sportsmanship

- Know, appreciate and understand the rules of the contest.
- Show respect for the officials. Good Sportsmanship implies the willingness to accept and abide by the decisions of the officials.
- Show respect for the opponent at all times. Good Sportsmanship is the Golden Rule in action.
- Recognize and appreciate the skill of performance regardless of team affiliation.
- 5. Maintain self control at all times. Good Sportsmanship is a responsibility of all who are involved in the game.
- Show a positive attitude in cheering, refraining from intimidation or negative cheering. Good Sportsmanship is cheering your own

Acts of Misconduct

- 1. Throwing of any object onto the playing floor or in the stands.
- Behavior deemed dangerous or which interferes with the rights of others to watch the game.
- 3. Possessing, consuming or being under the influence of chemicals.
- Use of obscene, profane or abusive language or gestures, signs, posters or banners which show disrespect for opponent's team, officials, cheerleaders, band or other performing groups.
- 5. The use of noise makers.
- Entry onto the playing surface at any time.
